

- That the school will not open classes under CBSE pattern particularly class IX/X and will not use CBSE name in any manner without obtaining affiliation.
- That State pattern classes IX & X running prior to the affiliation of CBSE would be sponsored at State Board Examination & State Pattern classes IX & X will be closed in a phased manner & State Pattern Class IX & X will not be opened on conferring upon Affiliation from CBSE.
